This application must be completed and returned to the Town of Fuquay-Varina Inspections Department along with all required supporting documentation before issuance of a permit. Highlighted permits above are required to have supportive documentation; the permit attendant or fire code enforcement officer will have those requirements. A site inspection is required to verify compliance with the NC State Fire Code.

### CONDITIONS OF PERMIT

A permit shall constitute permission to maintain, store or handle materials; or to conduct processes which produce conditions hazardous to life or property; or to install or modify any fire protection system or equipment or any other construction, equipment installation or modification in accordance with the provisions of the NC State Fire Code where a permit is required. Such permission shall not be construed as authority to violate, cancel or set aside any of the provisions of the NC State Fire Code or other applicable regulations or laws of the State of North Carolina or Town of Fuquay-Varina. The code official is authorized to revoke a permit issued under the provisions of this code when it is found by inspection or otherwise that there has been a false statement or misrepresentation as to the material facts in the application or construction documents on which the permit or approval was based including, but not limited to, any one of the following: 1. The permit is used for a location or establishment other than that for which it was issued; 2. The permit is used for a condition or activity other than that listed in the permit; 3. Conditions and limitations set forth in the permit have been violated; 4. The permit is used by a different person or firm than the name for which it was issued.
