This matter being heard by the Honorable Vince M. Rozier, Jr. on the Petition of the Fuquay-Varina Police Department for Release of Custodial Law Enforcement Agency Recording pursuant to N.C. Gen. Stat. §132-1.4A on February 24, 2021; and it appearing to the Court that the release should be authorized as set forth in the Petition.

IT IS THEREFORE ORDERED that the body worn camera (BWC) recordings dated January 30, 2021 related to the Fuquay-Varina Police Department Incident Report 2021-00170 be released to the public on the following terms:

1. Fuquay-Varina Police Department employees' personal cell phone photographs, cell phone screen information and cell phone lock screens (including unlocking codes) are to be redacted.
2. Fuquay-Varina Police Department employees' personal cell phone images of DCI/NCIC and other protected investigative information related to the ongoing Harnett Sheriff's office investigation are to be redacted.

3. All Fuquay-Varina Police Department in-car computer screens including Watchguard system screens are to be redacted.
4. All audio and visual recordings related to the Harnett County Sheriff's office ongoing criminal investigation are to be redacted.
5. All audio and visual recordings of identifying information related to the suspect involved in the Harnett County Sheriff's Office investigation are to be redacted.
6. All recordings of the portion of the bill of sale containing the suspect's identifying information are to be redacted.
7. All recordings of the faces of juveniles, except those of Malcom Zigler, are to be redacted as the parents of Malcom Zigler have requested and consented to the release of his images.
8. All recordings of personal identifying information of the reporting victim and her companion are to be redacted.
9. All recordings of faces of the reporting victim and her companion are to be redacted.
10. All audio and visual recordings of house numbers and vehicle registration plate numbers are to be redacted.
11. All recordings of any family photographs are to be redacted.
12. The Petitioner will cause these redactions to be made and the public release to be made in a reasonable and timely manner.
